**FORM 10-Q QUARTERLY REPORT FOR
THE THIRD QUARTER ENDED SEPTEMBER 27, 2015
OF SMITHFIELD FOODS, INC.**

On October 28, 2015 after trading hours (Hong Kong time), Smithfield released its Form 10-Q Quarterly Report for the third quarter ended September 27, 2015.

RESULTS OF SMITHFIELD AND FORM 10-Q QUARTERLY REPORT

Smithfield Foods, Inc. ("Smithfield") is a corporation incorporated in the Commonwealth of Virginia, the United States ("U.S."). As at the date of this announcement, Smithfield is an indirect wholly owned subsidiary of WH Group Limited (the "Company") and is not subject to the periodic reporting obligations under section 13 or 15(d) of the United States Securities Exchange Act of 1934. However, the indentures governing certain of Smithfield's senior debts contain covenants that require Smithfield to file such reports as if it were subject to those reporting requirements. Accordingly, Smithfield currently files with the United States Securities and Exchange Commission (the "SEC") annual reports on Form 10-K, quarterly reports on Form 10-Q and current reports on Form 8-K, as disclosed in the Company's prospectus dated July 24, 2014. These reports contain financial and other information regarding Smithfield and its subsidiaries.

Smithfield has, on October 28, 2015 after trading hours (Hong Kong time), filed its quarterly report with the SEC under Form 10-Q for the third quarter ended September 27, 2015 (the "Smithfield Quarterly Report"). It is important to note that the unaudited consolidated condensed financial results contained in Smithfield Quarterly Report have been prepared in accordance with accounting principles generally accepted in the U.S. The Company prepares its consolidated financial results in accordance with International Financial Reporting Standards ("IFRS"). Accordingly, Smithfield's results reported herein differ from Smithfield's results contained in the Company's consolidated financial statements, which include certain adjustments in order to conform to IFRS. These adjustments include the re-measurement of biological assets from cost to fair value through earnings, the reclassification of numerous balance sheet items primarily reflected in biological assets and deferred taxes, and classification changes within the financial results, primarily for distribution expenses, which have a significant impact on gross margin.

SUMMARY OF RESULTS OF SMITHFIELD FOR THE THREE MONTHS ENDED SEPTEMBER 27, 2015

For the three months ended September 27, 2015, Smithfield produced 3.7 million hogs in the U.S., representing an increase of 12% from the comparable period in 2014. Hogs processed in the U.S. amounted to 7.2 million heads, representing an increase of 15% from the comparable period of 2014. Packaged meat sales volume in the U.S. increased 5% to 0.3 million metric tons as compared to the comparable period for 2014. Sales decreased 8% from the comparable period of 2014 to US\$3,406.1 million. Net income decreased 46% from the comparable period of 2014 to US\$83.3 million.

SUMMARY OF RESULTS OF SMITHFIELD FOR THE NINE MONTHS ENDED SEPTEMBER 27, 2015

For the nine months ended September 27, 2015, Smithfield produced 11.5 million hogs in the U.S., representing an increase of 6% from the comparable period in 2014. Hogs processed in the U.S. amounted to 22.2 million heads, representing an increase of 12% from the comparable period of 2014. Packaged meat sales volume in the U.S. increased 6% to 0.94 million metric tons as compared to the comparable period for 2014. Sales decreased 4% from the comparable period of 2014 to US\$10,509.2 million. Net income decreased 29% from the comparable period of 2014 to US\$284.5 million.
