**Letter to New Registered Shareholders**

- (4) to receive both the printed English and Chinese versions of all future Corporate Communications.

You have the right at any time by reasonable notice in writing to the Company c/o the Hong Kong Share Registrar to change the choice of language and means of receipt of the Corporate Communications. You may also send such a notice by email to [whgroup.ecom@computershare.com.hk](mailto:whgroup.ecom@computershare.com.hk). Even if you have chosen (or are deemed to have consented) to receive the Website Version but for any reason have difficulty in receiving or gaining access to the Corporate Communications, the Company will upon your request send the Corporate Communications to you in printed form free of charge as soon as possible.
