The Share Repurchase Programme will be conducted pursuant to the Share Repurchase Mandate and in compliance with the articles of association of the Company, the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("Listing Rules"), the Codes on Takeovers and Mergers and Share Buy-backs, the laws of the Cayman Islands and all other applicable laws and regulations. The Shares repurchased under the Share Repurchase Programme will be cancelled.

The Company intends to finance the repurchase of Shares by its existing available cash reserves and/or available banking facilities.
