INTRODUCTION

The primary purpose of this circular is to provide you with information regarding the resolutions to be proposed at the Annual General Meeting and to give you notice of the Annual General Meeting. Resolutions to be proposed at the Annual General Meeting include ordinary resolutions relating to the Scrip Dividend Scheme, the grant of the Issue Mandate, the Repurchase Mandate and the Extension Mandate, and the re-election of Directors.

SCRIP DIVIDEND SCHEME

By the announcement of the results for the year ended 31 March 2016 of the Company dated 28 June 2016, the Directors announced that they had resolved to recommend the payment of a final dividend of HK1.0 cent per Share for the year ended 31 March 2016 to the Shareholders whose names appear on the register of members of the Company on the Record Date and also to recommend the Scrip Dividend Scheme to the Qualifying Shareholders, subject to the approval of the Shareholders on the payment of final dividend by way of the Scrip Dividend Scheme at the Annual General Meeting and the grant by the Listing Committee of the Stock Exchange of the listing of, and permission to deal in, the Scrip Shares to be allotted and issued pursuant thereto.

In arriving at the decision to recommend the Scrip Dividend Scheme to the Shareholders, the Directors consider that while the Company should declare a final dividend for the financial year ended 31 March 2016, the retention of cash, which would otherwise have been paid to the Shareholders as a cash dividend, within the Group would enhance the continuous growth, maintain the financial stability and reduce the financing costs of the Group. On the other hand, the Scrip Dividend Scheme will give those Qualifying Shareholders who wish to further invest in the Company the opportunity to increase their equity investment in the Company.

Qualifying Shareholders are entitled to elect to have the final dividend to be made payable to them wholly in cash or in Shares or partly in cash and in Shares. Shareholders whose registered addresses are outside Hong Kong as shown in the register of members of the Company on the Record Date (if any) may not be permitted to participate in the Scrip Dividend Scheme if the Directors consider that the circulation of an offer of such election to such Shareholders would or might be unlawful or impracticable and accordingly no form of election will be sent to such Shareholders and they will receive the final dividend wholly in cash. As at the Latest Practicable Date, no Shareholders had a registered address outside Hong Kong as appeared on the register of members of the Company. Should there be any Shareholder whose registered address is outside Hong Kong as shown in the register of members of the Company on the Record Date, the Company will make enquiry regarding the legal restrictions under the laws of the relevant place and the requirements of the relevant regulatory body or stock exchange for considering whether to exclude such Shareholder from the Scrip Dividend Scheme and it may only exclude such Shareholder on the basis that, having made such enquiry, it would be necessary or expedient to do so.

For the purpose of calculating the number of Scrip Shares, the value of the Scrip Shares will be fixed by the Board at its discretion with reference to the average of the closing prices of the Shares on the Stock Exchange for the five consecutive trading days ending on (and including) the Record Date less a discount of 5% of such average price or the par value of Shares, whichever is higher. The number of Scrip Shares to be issued will be rounded down to the nearest whole number of Scrip Shares and no Qualifying Shareholder is entitled to be allotted and issued any fraction of a Scrip Share under the Scrip Dividend Scheme. The last day for dealing in Shares cum entitlements to the proposed final dividend for the year ended 31 March 2016 will be Monday, 29 August 2016. Shareholders are reminded that in order to qualify for the proposed final dividend for the year ended 31 March 2016, all transfers of Shares accompanied by the relevant share certificate and transfer forms must be lodged with the Company's Hong Kong branch share registrar, Tricor Secretaries Limited, at Level 22, Hopewell Centre, 183 Queen's Road East, Hong Kong not later than 4:30 p.m. on Wednesday, 31 August 2016.

Subject to the approval by the Shareholders of the Scrip Dividend Scheme at the Annual General Meeting and the grant by the Listing Committee of the Stock Exchange of the listing of, and permission to deal in, the Scrip Shares on the Stock Exchange, the share certificates for the Scrip Shares are expected to be despatched on or around Friday, 28 October 2016 and the dealings in the Scrip Shares on the Stock Exchange are expected to commence on or around Monday, 31 October 2016.

ISSUE MANDATE

At the Annual General Meeting, an ordinary resolution will be proposed that the Directors be given the Issue Mandate. As at the Latest Practicable Date, a total of 2,772,228,686 Shares were in issue. Subject to the passing of the proposed resolution granting the Issue Mandate to the Directors and on the basis that no Shares will be issued or repurchased by the Company prior to the Annual General Meeting, the Company will be allowed under the Issue Mandate to issue a maximum of 554,445,737 Shares.

REPURCHASE MANDATE AND EXTENSION MANDATE

At the Annual General Meeting, an ordinary resolution will also be proposed to give the Directors the Repurchase Mandate.

This Appendix serves as an explanatory statement, as required by the Listing Rules, to provide the requisite information to enable you to make an informed decision whether to vote in favour of or against the resolution to approve the grant of the Repurchase Mandate to the Directors.

LISTING RULES RELATING TO THE REPURCHASE OF SECURITIES

The Listing Rules permit companies whose primary listings are on the Stock Exchange to repurchase their securities on the Stock Exchange subject to certain restrictions, the most important of which is summarised below. The Company is empowered by its memorandum of association and the Bye-laws to repurchase its own securities.

SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 2,772,228,686 Shares.

Subject to the passing of the proposed resolution for the grant of the Repurchase Mandate and on the basis that no Shares are allotted and issued or repurchased by the Company prior to the Annual General Meeting, the Company will be allowed under the Repurchase Mandate to repurchase a maximum of 277,222,868 Shares.

REASONS FOR THE REPURCHASE

The Directors believe that the Repurchase Mandate is in the best interests of the Company and the Shareholders. An exercise of the power of the Repurchase Mandate may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share. Such an exercise will only be made if the Directors believe that a repurchase of Shares will benefit the Company and the Shareholders.

FUNDING OF REPURCHASES

In repurchasing securities, the Company may only apply funds legally available for such purpose in accordance with its memorandum of association and the Bye-laws, the Listing Rules and the applicable laws of Bermuda.

Repurchase must be funded out of funds which are legally available for the purpose and in accordance with the memorandum of association and the Bye-laws and the Companies Act. Under the Companies Act, a company may only repurchase its own securities out of capital paid up on its shares to be repurchased or out of the funds of the company which would otherwise be available for dividend or distribution or out of the proceeds of a fresh issue of shares made for the purpose.

Any amount of premium payable on a repurchase over the par value of the shares may only be effected out of funds of the company which would otherwise be available for dividend or distribution or out of the company's share premium account. Such purchase may not be made if, on the date the purchase is to be effected, there are reasonable grounds for believing that the Company is, or after the purchase would be, unable to pay its liabilities as they become due.

Taking into account the current working capital position of the Group, the Directors consider that, if the Repurchase Mandate were to be exercised in full, it might have a material adverse effect on the working capital and/or the gearing position of the Group as compared with that as at 31 March 2016, being the date of its latest published audited consolidated accounts. However, the Directors do not intend to make any repurchases to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements and/or the gearing position of the Group which in the opinion of the Directors are from time to time appropriate for the Group.

DISCLOSURE OF INTERESTS

None of the Directors or, to the best of their knowledge, having made all reasonable enquiries, their associates (as defined in the Listing Rules), have any present intention to sell to the Company or its subsidiaries any of the securities in the Company if the grant of the Repurchase Mandate is approved at the Annual General Meeting and exercised.

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the power of the Company to make purchases of the Shares pursuant to the Repurchase Mandate in accordance with the Listing Rules, the applicable laws of Bermuda and the regulations set out in the memorandum of association of the Company and the Bye-laws.

If a Shareholder's proportionate interest in the voting rights of the Company increases on the Company exercising its powers to repurchase securities pursuant to the Repurchase Mandate, such increase will be treated as an acquisition for the purposes of Rule 32 of the Takeovers Code. As a result, a Shareholder or group of Shareholders acting in concert could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rules 26 and 32 of the Takeovers Code.

As at the Latest Practicable Date, to the best of the knowledge and belief of the Directors, Mr. Li Ming Hung and Mr. Chen Tien Tui ("Concert Party"), being parties acting in concert as defined under the Takeovers Code, were interested in approximately an aggregate of 31.0% of the then existing issued Shares and Fiducia Suisse SA was interested in approximately 30.9% of the then existing issued Shares. On the basis of 2,772,228,686 Shares prior to the date of the Annual General Meeting, if the Repurchase Mandate were exercised in full, the percentage interest of the Concert Party and Fiducia Suisse SA would increase to approximately 34.4% and 34.3% respectively of the then issued Shares.

On the basis of the current shareholding of the Concert Party and Fiducia Suisse SA, an exercise of the Repurchase Mandate in full will result in the Concert Party, Fiducia Suisse SA and their respective concert parties becoming obliged to make a mandatory offer under the Takeovers Code.

The Directors have no intention to exercise the Repurchase Mandate to such an extent that will result in any of the Concert Party and their respective concert parties becoming obliged to make a mandatory offer under the Takeovers Code.

As at the Latest Practicable Date, no connected person of the Company had notified the Company that he/she/it had a present intention to sell any securities of the Company nor had such connected person undertaken not to sell any of the securities held by him/her/it to the Company in the event that the Repurchase Mandate is granted.

SECURITIES REPURCHASE MADE BY THE COMPANY

The Company has not purchased any of the Shares (whether on the Stock Exchange or otherwise) during the six months immediately preceding the date of this circular.

PARTICULARS OF DIRECTORS FOR RE-ELECTION

The particulars of the Directors eligible for re-election at the Annual General Meeting are set out below:

Mr. Lee Yuen Chiu, Andy ("Mr. Lee")

Mr. Lee, aged 51, is an executive Director and a director of Best Linkage (Macao Commercial Offshore) Limited, a subsidiary of the Company. He has over 30 years' experience in the textile industry and is responsible for the overall management of the sales and production of the Group. Mr. Lee joined the Group in 1997.

Save as disclosed above, in the three years immediately preceding the Latest Practicable Date, Mr. Lee had not held any directorship in listed public companies or other major appointments and qualifications. Save as disclosed above, Mr. Lee did not hold any other position with the Company or other members of the Group.

As at the Latest Practicable Date, Mr. Lee was interested in 5,000,000 underlying Shares (being Shares to be allotted on exercise of share options granted under the share option scheme of the Company), representing approximately 0.18% of the issued share capital of the Company as at the Latest Practicable Date, within the meaning of Part XV of the SFO. Apart from being an executive Director, Mr. Lee is not related to any other Directors, senior management, substantial Shareholders or controlling Shareholders of the Company.

Mr. Lee has entered into a service contract with the Company for an initial term of three years with effect from 1 April 2012 and the terms shall continue thereafter unless either party terminate the service contract by giving to the other party at least six months' notice in writing or any termination event specified in the service contract occurs. For the year ended 31 March 2016, Mr. Lee was paid an annual salary of approximately HK\$2.36 million and was entitled to the use of a private car provided by the Group. Mr. Lee's remuneration is determined with reference to his performance and contribution to the Group.

Mr. Choi Lin Hung ("Mr. Choi")

Mr. Choi, aged 54, is an executive Director. He holds a Master in Business Administration and is responsible for the strategic planning and corporate development of the Group. Prior to joining the Group in 2001, Mr. Choi has over 9 years' banking experience and 6 years' management experience in garment and textile industry. As at the Latest Practicable Date, Mr. Choi was a director of a number of subsidiaries and associated corporations of the Group. Mr. Choi resigned from his positions the chairman, chief executive officer and an executive director of Highlight China IoT International Limited (formerly known as Ford Glory Group Holdings Limited, a former subsidiary of the Company), a company listed on the Main Board of the Stock Exchange on 16 August 2014.

Save as disclosed above, Mr. Choi did not hold any other position with the Company or other members of the Group. Save as disclosed, in the three years immediately preceding the Latest Practicable Date, Mr. Choi had not held any directorship in any other listed public companies or other major appointments and qualifications.

As at the Latest Practicable Date, Mr. Choi was interested in 8,500,000 Shares and 12,000,000 underlying Shares (being Shares to be allotted on exercise of share options granted under the share option scheme of the Company) in the Company, representing approximately 0.31% and 0.43% respectively of the issued share capital of the Company as at the Latest Practicable Date, within the meaning of Part XV of the SFO. Apart from being an executive Director, Mr. Choi is not related to any other directors, senior management, substantial shareholders (as defined under the Listing Rules) or controlling shareholders (as defined under the Listing Rules) of the Company.

Mr. Choi has entered into a service contract with the Company for an initial term of three years with effect from 1 April 2012 and the term shall continue thereafter unless either party terminate the service contract by giving to the other party at least six months' notice in writing or any termination event specified in the service contract occurs. His appointment is subject to retirement by rotation and re-election at annual general meeting of the Company in accordance with the Bye-laws. For the year ended 31 March 2016, Mr. Choi was entitled under the service contract to a salary and a bonus which in aggregate amount to approximately HK\$4.44 million and was entitled to the use of a private car provided by the Group. Mr. Choi's remuneration is determined with reference to his performance and contribution to the Group.

Mr. Kwok Sze Chi ("Mr. Kwok")

Mr. Kwok, aged 61, is an independent non-executive Director, who currently holds a registered investment adviser licence and is a director of The Institute of Securities Dealers Limited and a vice chairman of The Hong Kong Institute of Financial Analysts and Professional Commentators Limited. Having served the securities industry for over 30 years, Mr. Kwok has vast experience in securities and futures investment and operation. Since 1985, Mr. Kwok has been invited to appear on television and radio programmes to explain market trends and to analyse stock market developments. He also provides professional investment analysis in newspapers and investment websites. Mr. Kwok joined the Group in 2006.

Mr. Kwok is an executive director of Bright Smart Securities & Commodities Group Limited which is a company listed on the Main Board of the Stock Exchange. Save as disclosed above, in the three years immediately preceding the Latest Practicable Date, Mr. Kwok had not held any directorship in listed public companies or other major appointments and qualifications. Save as disclosed above, Mr. Kwok does not hold any other position with the Company or other members of the Group.

As at the Latest Practicable Date, Mr. Kwok did not have any interest in the Shares or underlying Shares within the meaning of Part XV of the SFO. Apart from being an independent non-executive Director, Mr. Kwok is not related to any other Directors, senior management, substantial shareholders or controlling Shareholders of the Company.

For the year ended 31 March 2016, Mr. Kwok was paid an annual director's fee of HK\$240,000 as determined by the Board with regard to the expected time to be spent by Mr. Kwok on the affairs of the Company. Mr. Kwok has not entered into any service contract with the Company or any of its subsidiaries.

His appointment was renewed on 1 April 2013 for an initial term of two years commencing from 1 April 2013, renewable automatically for successive term of one year commencing from the next day after the expiry of the then current term, unless terminated by not less than three months' notice in writing.

Mr. Kwok joined the Group in 2006 and has served as an independent non-executive Director for more than nine years. The Company has continued to receive written confirmation from him annually on his independence, and by reference to the Listing Rules which sets out certain criteria on independence of the independent non-executive Director, the Board considers that Mr. Kwok is independent. Further, in view of the extensive knowledge and experience of Mr. Kwok, the Board believes that his re-election is in the best interests of the Company and the Shareholders as a whole. Pursuant to code provision A.4.3 of the CG Code, a separate ordinary resolution will be proposed at the Annual General Meeting to approve the re-election of Mr. Kwok as an independent non-executive Director.
