GENERAL MANDATES TO ISSUE NEW SHARES AND REPURCHASE SHARES

This appendix includes an explanatory statement required by the Stock Exchange to be presented to the Shareholders concerning the Repurchase Mandate proposed to be granted to the Directors.

1. LISTING RULES FOR REPURCHASES OF SHARES

The Listing Rules permit companies with a primary listing on the Stock Exchange to repurchase their shares on the Stock Exchange subject to certain restrictions.

The Listing Rules provide that all proposed repurchases of shares by a company with a primary listing on the Stock Exchange must be approved by shareholders in advance by an ordinary resolution at a general meeting, either by way of a general mandate or by a specific approval of a particular transaction and that the shares to be repurchased must be fully paid up.

2. FUNDING AND IMPACT OF REPURCHASES

Any repurchase will be made out of funds which are legally available for the purpose in accordance with the memorandum of association of the Company and Articles, the Listing Rules and the applicable laws of the Cayman Islands. As compared with the financial position of the Company as at 30 June 2014 (being the date to which the latest audited accounts of the Company have been made up), the Directors consider that there would not be a material adverse impact on the working capital and on the gearing position of the Company in the event that the proposed repurchases were to be carried out in full during the proposed repurchase period.

The Directors do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital of the Company or the gearing position which in the opinion of the Directors are from time to time appropriate for the Company.

As a result, a Shareholder or a group of Shareholders acting in concert (as that term is defined in the Takeovers Code), depending on the level of increase of the shareholding, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date and insofar the Directors are aware of, (i) Key Wise Group Limited ("Key Wise"), which owned 559,712,145 Shares (approximately 41.53% of the issued share capital of the Company); (ii) Cheer Sky Limited ("Cheer Sky"), which owned 49% interest in Key Wise and therefore is deemed or taken to be interested in all the Shares held by Key Wise under the SFO; (iii) Mr. Sin Ke, who owned 51% interest in Cheer Sky and his spouse, Ms. Hong Man Na, who owned 51% interest in Key Wise, and therefore is deemed or taken to be interested in all the Shares held by Key Wise under the SFO; and (iv) Ms. Hong Man Na, who owned 51% interest in Key Wise and therefore is deemed or taken to be interested in all the Shares held by Key Wise. In the event that the Repurchase Mandate was exercised in full, the total interests of Key Wise, Cheer Sky, Mr. Sin Ke and Ms. Hong Man Na would be increased to approximately 46.14%, 46.14%, 46.14% and 46.14% respectively. On the basis of the aforesaid increase of shareholding, Key Wise, Cheer Sky, Mr. Sin Ke and Ms. Hong Man Na will be obliged to make a mandatory offer under Rule 26 of the Takeovers Code if the Repurchase Mandate was exercised in full. The Directors do not intend to exercise the power to repurchase Shares to an extent which would render any Shareholder or group of Shareholders obliged to make a mandatory offer under Rule 26 of the Takeovers Code. The Directors have no

intention to exercise the Repurchase Mandate to such an extent that will result in a public shareholding of less than the minimum public float requirement of 25% of the total issued share capital of the Company.
