**THIRD SUPPLEMENTAL S&P AGREEMENT

WAIVER FOR FURTHER DELAY IN DESPATCH OF CIRCULAR**

Reference is made to the announcements (the “**Announcements**”) of Bisu Technology Group International Limited (the “**Company**”) dated 31 December 2017, 22 January 2018, 24 January 2018, 12 February 2018 and 14 February 2018 in relation to, among other matters, the 3rd Supplemental S&P Agreement to make certain amendments to the Sale and Purchase Agreement (as amended and supplemented by the Supplemental S&P Agreements) to settle the differences in respect of the 2nd Guaranteed Profit subject to the conditions precedent under the 3rd Supplemental S&P Agreement being satisfied. Unless the context requires otherwise, capitalised terms used in this announcement shall have the same meanings as those defined in the Announcements.

As disclosed in the Announcements, the Circular containing, among other matters, further details of the 3rd Supplemental S&P Agreement and the transactions contemplated thereunder was expected to be despatched to the Shareholders on or before 12 March 2018.

As additional time is required for the Company to prepare and finalise certain information for inclusion in the Circular, the Company hereby announces that it has applied to the Stock Exchange for a waiver to further delay the despatch of the Circular pursuant to Rule 14.41(a) of the Listing Rules. Further announcement will be made by the Company in respect of the expected date of despatch of the Circular.
