If that instrument is signed by an attorney of the shareholder, the power of attorney authorising that attorney to sign the form of proxy or other authorisation documents must be notarised.			

- Each holder of domestic shares is entitled to appoint in writing one or more proxies, whether a shareholder or not, to attend and vote on his behalf at the Meeting. Notes (1) to (6) also apply to holders of domestic shares, except that the form of proxy or other documents of authority must be delivered to the Office of the Board of Directors of the Company, at 26/F., Union Building, No. 100 Yan'an East Road, Shanghai, the PRC (post code 200002) not later than 24 hours before the time appointed for holding the Meeting (i.e. not late than Thursday, 18 June 2020 at 1:30 p.m.) or any adjournment thereof in order for such documents to be valid.
 The proxy appointed need not be a member of the Company but must attend the Meeting in person to represent you.
- 10. Completion and delivery of the form of proxy will not preclude you from attending and voting in person at the Meeting if you so wish. In such event, the instrument appointing a proxy shall be deemed to be revoked.

In the case of joint holders of any share, only the joint holder whose name stands first in the register of members is entitled to cast a vote, either in person or by proxy, in respect of such shares as if he were solely entitled thereto. However, if more than one of such joint holders is present at the Meeting, in person or by proxy, the vote in respect of such shares of the joint holder whose name stands first in the register of members of the Company and who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of the votes of the other joint holder(s).

For holders of H shares, this form of proxy together with the power of attorney (if any) or other authorisation documents (if any) under which it is signed or a notarially certified copy thereof, must be deposited to the Company's H share registrar and transfer office, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not later than 24 hours before the time appointed for holding the Meeting (i.e. not later than Thursday, 18 June 2020 at 1:30 p.m.) or any adjournment thereof in order for such documents to be valid.

* The Company is registered as a non-Hong Kong company as defined in the Companies Ordinance (Chapter 622 of the Laws of Hong Kong) under its Chinese name and the English name "Shanghai Jin Jiang Capital Company Limited".
