POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 18 APRIL 2019

All the Ordinary Resolutions set out in the AGM Notice were duly passed by the Shareholders by way of poll at the AGM.

Reference is made to the circular dated 19 March 2019 (the “Circular”) of Tsit Wing International Holdings Limited (the “Company”). Unless the context requires otherwise, terms used herein shall have the same meanings as those defined in the Circular.

The Board is pleased to announce that all the Ordinary Resolutions set out in the notice of the AGM dated 19 March 2019 (the “AGM Notice”) were duly passed by the Shareholders by way of poll at the AGM.

As at the date of the AGM, there were 762,286,112 issued Shares entitling the Shareholders to attend and vote for or against the Ordinary Resolutions at the AGM. There were no Shares entitling the Shareholders to attend but abstain from voting in favour of the Ordinary Resolutions at the AGM as set out in Rule 13.40 of the Listing Rules.

None of the Shareholders were required under the Listing Rules to abstain from voting on the Ordinary Resolutions at the AGM. None of the Shareholders have stated in the Circular their intention to vote against or to abstain from voting on any of the Ordinary Resolutions at the 2018 AGM.
