In order to be valid, the written authorization or authorization documents which have been notarized, if any, together with this completed proxy form must be delivered by the holder(s) of H share(s) to the H share registrar of the Company, Tricor Abacus Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong, no less than 24 hours before the time of the holding of the H Share Class Meeting.
