

- 遵守香港及其他地區的適用法律及法規;
- 以證券持有人(包括香港結算代理人(如適用))的 名義登記新發行證券或轉讓或受讓證券;
- 存置或更新本公司證券持有人的名册;
- 核實證券持有人的身份;
- 確定本公司證券持有人的受益權利,例如股息、 供股和紅股等;
- 分發本公司及其附屬公司的通訊;
- 編製統計數據和證券持有人資料;
- 披露有關資料以便就權益索償;及
- 與上述有關的任何其他附帶或相關目的及/或 使本公司及香港證券登記處能履行對證券持有 人及/或監管機構承擔的責任及/或證券持有 人不時同意的任何其他目的。

3. 轉交個人資料

本公司及其香港證券登記處所持有關證券持有人的個人資料將會保密,但本公司及其香港證券登記處可以在為達到上述任何目的之必要情況下,向下列任何人士披露,獲取或轉交(無論在香港境內或境外)有關個人資料:

- 本公司委任的代理人,例如財務顧問、收款銀 行和海外證券登記總處;
- (如證券申請人要求將證券存於中央結算系統)香港結算或香港結算代理人,彼等將會就中央結算系統的運作使用有關個人資料;
- 本公司或香港證券登記處就其各自業務營運而 使用有關個人資料;
- 向本公司或香港證券登記處提供與其各自業務 營運有關的行政、電訊、電腦、付款或其他服務 的任何代理人、承包商或第三方服務供應商;
- 香港聯交所、證監會及任何其他法定監管機關 或政府部門或遵照其他法例、規則或法規;及
- 證券持有人與其進行或擬進行交易的任何人士 或機構,例如彼等的銀行、律師、會計師或股 票經紀等。

4. 個人資料的保留

本公司及其香港證券登記處將按收集個人資料所需的用途保留證券申請人及持有人的個人資料。毋須 保留的個人資料將會根據《條例》銷毀或處理。

5. 查閱和更正個人資料

證券持有人有權確定本公司或香港證券登記處是否 持有其個人資料,並有權索取有關該資料的副本並 更正任何不準確資料。本公司和香港證券登記處有 權就處理任何查閱資料的要求收取合理費用。

所有查閱資料或更正資料的要求應按招股章程「公司 資料」一節所披露或不時通知的本公司註冊地址送交 公司秘書,或向本公司的香港證券登記處的個人資 料私隱事務主任提出。

閣下簽署申請表格或向香港結算發出電子認購指示, 即表示同意上述各項。
