The Board wishes to inform the shareholders of the Company and potential investors that the Group's consolidated results for the three months ended 31 March 2013 is expected to record a loss as compared to a profit recorded with the corresponding period in 2012.

This announcement is made pursuant to rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (the "SFO").

The board of directors (the "Board") of Lingbao Gold Company Ltd. (the "Company" and together with its subsidiaries, the "Group") wishes to inform the shareholders of the Company and potential investors that the Group's consolidated results for the three months ended 31 March 2013 is expected to record a loss as compared to a profit recorded with the corresponding period in 2012. The loss of the group was mainly due to the rise of raw material cost in the smelting business, the increase in finance expense and the write-down in value of inventory as a result of decrease in commodity prices .

This profit warning announcement is only based on the preliminary review on the unaudited management accounts of the Group and the current information available, which has not been confirmed nor audited by the Company's auditor. The results of the Group for the three months ended 31 March 2013 will be announced by the end of April 2013.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.
