INTRODUCTION

The purpose of this circular is to provide you with information relating to the proposals to be put forward at the Annual General Meeting for the granting of the General Mandate and the Repurchase Mandate, the extension of the General Mandate by adding to it the number of Shares repurchased by the Company under the Repurchase Mandate, the re-election of the retiring Director, the appointment of executive Director, non-executive Director and independent non-executive Director and the declaration of final dividend, together with the notice of the Annual General Meeting.

GENERAL MANDATE

At the Annual General Meeting, an ordinary resolution will be proposed to grant the General Mandate to the Directors to exercise the powers of the Company to allot, issue and deal with Shares up to 20% of the number of the issued Shares as at the date of passing of the relevant resolution.

As at the Latest Practicable Date, the number of issued Shares was 1,960,000,000 Shares. Subject to the passing of the relevant resolution and on the basis that no further Shares are issued or repurchased after the Latest Practicable Date and up to the Annual General Meeting, the Company will be allowed to issue up to 392,000,000 Shares pursuant to the General Mandate.

Subject to approval by a separate resolution at the Annual General Meeting, the number of Shares purchased by the Company under the Repurchase Mandate will be added to extend the General Mandate provided that such additional amount shall not exceed 10% of the number of the issued Shares as at the date of passing the resolutions in relation to the General Mandate and Repurchase Mandate.

REPURCHASE MANDATE

In addition, an ordinary resolution will be proposed by the Company at the Annual General Meeting to approve the granting of the Repurchase Mandate to the Directors to exercise the powers of the Company to repurchase Shares representing up to 10% of the number of the issued Shares as at the date of passing of the relevant resolution.

An explanatory statement required by the Listing Rules to be sent to the Shareholders in connection with the Repurchase Mandate is set out in Appendix III to this circular. The explanatory statement contains all information reasonably necessary to enable the Shareholders to make an informed decision on whether to vote for or against the relevant resolution at the Annual General Meeting.

Subject to the approval of the above resolutions by the Shareholders at the Annual General Meeting, the General Mandate and the Repurchase Mandate will expire at the earliest of: (i) the conclusion of the next annual general meeting of the Company; (ii) the expiration of the period within which the next annual general meeting of the Company is required by any applicable laws or the Articles of Association to be held; or (iii) the revocation or variation of the authorities by an ordinary resolution of the Shareholders at a general meeting of the Company.

RE-ELECTION OF RETIRING DIRECTOR

In accordance with article 84(1) of the Articles of Association, Mr. Yang Jiye, Mr. Kenneth Lee and Mr. Ma Qingshan will retire by rotation at the Annual General Meeting. Mr. Yang Jiye, being eligible, will offer himself for re-election at the Annual General Meeting while the other retiring Directors, Mr. Kenneth Lee and Mr. Ma Qingshan, will not offer themselves for re-election at the Annual General Meeting as they would like to devote more time to pursuing their own personal commitments.

Nomination procedures for Directors

The nomination committee of the Company (the "Nomination Committee") shall recommend to the Board on the appointment of Directors (including independent non-executive Directors) in accordance with the following selection criteria and nomination procedures:

- the Nomination Committee shall make proactive communications with relevant departments of the Company, study the Company's demand for new Directors, and make reports in writing in respect thereof:
- 2. the Nomination Committee may seek candidates for Directors in a broad scope in the Company and the Group, and from the talent market;
- 3. collect and assess the following information and aspects about the candidates, and form writing materials, including but not limited to:
 - 3.1 diversity in all aspects, including gender, age, cultural and educational background, professional experience, skills, knowledge and work experience;
 - 3.2 qualifications, including the achievements and experience in relevant industries related to the business of the Group;
 - 3.3 willingness to devote sufficient time to perform the duties as member of the Board and other responsibilities as a Director;
 - 3.4 integrity and reputation;
 - 3.5 independence of candidates for independent non-executive Directors, which is assessed with reference to the factors as set out in Rule 3.13 of the Listing Rules and any other factors deemed as appropriate by the Nomination Committee or the Board;
 - 3.6 potential contributions to the Board; and
 - 3.7 other relevant aspects that apply to the business of the Group.
- 4. seek the nominee's consent to nomination, otherwise, the nominee cannot be a candidate for a Director;
- 5. convene a Nomination Committee meeting to examine the qualifications of the candidate against the criteria for the Directors;
- 6. make recommendations to the Board regarding the candidates for Directors and submit the relevant information to the Board one to two weeks prior to the election of new Directors; and
- 7. take other follow-up actions according to the decision and feedback from the Board.

Recommendations of the Nomination Committee

The Nomination Committee has assessed the independence of each of the independent non-executive Directors based on the independence criteria as set out in Rule 3.13 of the Listing Rules by reviewing the written confirmation of independence for 2023 submitted to the Company by each of them, and confirmed that all of them are independent.

In addition, the Nomination Committee has assessed and are satisfied with the performance of each of the retiring Directors for the year ended 31 December 2023. Therefore, the Nomination Committee nominated the retiring Director, Mr. Yang Jiye, to join the Board and recommended the Shareholders to re-elect him as the Director at the Annual General Meeting.

In particular, the Nomination Committee is also of the view that the Director, Mr. Yang Jiye, who is proposed to be subject to re-election at the Annual General Meeting would bring to the Board his own perspectives, skills and experience, as further described in his biographies in Appendix I to this circular. Based on the board diversity policy adopted by the Company, the Nomination Committee considers that Mr. Yang Jiye can contribute to the diversity of the Board, in particular, with his in-depth knowledge in the mining industry and corporate governance and management.

Therefore, in response to the recommendation of the Nomination Committee, the Board recommended the retiring Director, Mr. Yang Jiye, to be re-elected as the Director at the Annual General Meeting. As a good corporate governance practice, Mr. Yang Jiye will abstain from voting at the relevant Board meeting on the relevant resolution to recommend his re-election by the Shareholders at the Annual General Meeting.

Details of the retiring Director who offered himself for re-election at the Annual General Meeting are set out in Appendix I to this circular. Further information on the composition and the diversity of the Board and the attendance records of the Directors (including the retiring Directors) at the Board meetings and/or the meetings of the committees under the Board and general meetings are disclosed in the Corporate Governance Report as contained in the 2023 Annual Report of the Company.

APPOINTMENT OF EXECUTIVE DIRECTOR, NON-EXECUTIVE DIRECTOR AND INDEPENDENT NON-EXECUTIVE DIRECTOR

Reference is made to the announcement of the Company dated 19 March 2024 in relation to, among others, the retirement of Mr. Kenneth Lee as a non-executive Director, the retirement of Mr. Ma Qingshan as an independent non-executive Director, the proposed appointment of Ms. Zhang Jing as an executive Director, the proposed appointment of Mr. Zhao Yanchao as a non-executive Director and the proposed appointment of Mr. Zhao Bingwen as an independent non-executive Director with effect from the conclusion of the Annual General Meeting to fill up the vacancies opened from the retirement of Mr. Kenneth Lee and Mr. Ma Qingshan. If the proposed appointment is approved by the Shareholders at the Annual General Meeting, Mr. Zhao Yanchao will be appointed as a member of the remuneration committee of the Company (the "Remuneration Committee") and Mr. Zhao Bingwen will be appointed as a member of each of the Remuneration Committee and the audit committee of the Company following Mr. Kenneth Lee and Mr. Ma Qingshan's retirement at the conclusion of the Annual General Meeting. Ms. Zhang Jing will continue to serve as the secretary of the Board and a joint company secretary of the Company upon her appointment.

The Company has a nomination policy in place which set out the criteria and procedures when considering the candidates to be appointed or re-appointed as directors of the Company. The Nomination Committee has reviewed the skills, knowledge, experience and qualifications of Ms. Zhang Jing, Mr. Zhao Yanchao and Mr. Zhao Bingwen when making the recommendation to the Board for the proposed appointment of Ms. Zhang Jing, Mr. Zhao Yanchao and Mr. Zhao Bingwen at the Annual General Meeting. In addition, the Nomination Committee has also taken into account the diversity aspects (including but not limited to gender, age, cultural and educational background, ethnicity, professional and business experiences, skills, knowledge and length of service) set out in the board diversity policy of the Company.

The Nomination Committee was of the view that Ms. Zhang Jing, Mr. Zhao Yanchao and Mr. Zhao Bingwen met the criteria set out in the nomination policy and has recommended to the Board on the proposed appointment of Ms. Zhang Jing as an executive Director, Mr. Zhao Yanchao as a non-executive Director and Mr. Zhao Bingwen as an independent non-executive Director at the Annual General Meeting. The Board believes that the proposed appointment of Ms. Zhang Jing, Mr. Zhao Yanchao and Mr. Zhao Bingwen will bring additional experience, knowledge and new insights to the Board and promote the diversity of the Board in terms of gender, age, cultural and educational background and professional and business experiences. Mr. Zhao Bingwen has confirmed his independence pursuant to Rule 3.13 of the Listing Rules. The Nomination Committee has also assessed and was satisfied with the independence of Mr. Zhao Bingwen.

Details of Ms. Zhang Jing, Mr. Zhao Yanchao and Mr. Zhao Bingwen proposed to be appointed at the Annual General Meeting are set out in Appendix II to this circular.

APPENDIX I DETAILS OF DIRECTOR PROPOSED FOR RE-ELECTION

The followings are the particulars of the retiring Director who offered himself for re-election at the Annual General Meeting.

Mr. Yang Jiye ("Mr. Yang"), aged 46, is an executive Director, Chairman of the Board and chief executive officer and president of the Company. Meanwhile, he is also the chairman of the board of directors of Fushun Hanking Aoniu Mining Limited, director of Hanking Australia Investment Pty Ltd ("Hanking Australia") and Fushun Hanking D.R.I. Co., Ltd. Mr. Yang is currently serving as the chairman of the board of directors of Liaoning Hanking Investment Co., Ltd. Mr. Yang is the chairman of the Nomination Committee and a member of the health, safety, environmental protection and community committee of the Company. With his previous and current positions in the Group, he has more than 20 years of experience in corporate governance and management.

As at the Latest Practicable Date, Mr. Yang holds 1,314,061,666 long position Shares, representing approximately 67.04% of the issued Shares and 4,000,000 short position Shares, representing approximately 0.20% of the issued Shares, and holds interest in 6,300,000 shares in Hanking Australia, representing approximately 3% of the issued shares of Hanking Australia. Mr. Yang is the son of Ms. Yang Min, a controlling Shareholder of the Company.

Mr. Yang has entered into a director service agreement with the Company for a term of three years commencing from 17 March 2024 which is subject to termination in accordance with the terms thereof. Mr. Yang's directorship is also subject to the retirement by rotation and re-election at annual general meeting of the Company in accordance with the Articles of Association. Mr. Yang is not entitled to any director's fee, but he is entitled to receive a salary of RMB2,000,000 per annum for his management services to the Group. Mr. Yang's annual emolument would be determined with reference to various factors such as his duties and performance as well as comparable market conditions and based on the recommendation from the Remuneration Committee and subject to the annual review conducted by the Remuneration Committee.

Ms. Zhang Jing ("Ms. Zhang"), aged 43, is currently the secretary of the Board and a joint company secretary of the Company. Ms. Zhang joined the Company in March 2011 and has previously served as the manager of the compliance department, director-general of the office of the Board and manager of the investor relationship department, as well as the supervisor of Fushun Hanking Aouniu Mining Co., Ltd, a subsidiary of the Company. Ms. Zhang obtained the bachelor degree of law from China University of Political Science and Law in July 2003 and then obtained the master degree specialising in international business law and European Union law from the University of Sheffield in the UK in November 2004. Ms. Zhang served as a practising lawyer in a law firm from February 2005 to February 2009, providing corporate and securities legal services, where she acted as a legal consultant for a number of listed companies. With the past and current positions she held in the Group, Ms. Zhang has over 15 years of experience in corporate governance, listing compliance as well as investor relationship management.

As at the Latest Practicable Date, Ms. Zhang holds 531,000 Shares in her personal capacity.

The Company has entered into a director service agreement with Ms. Zhang for a term of three years commencing from the effective date of her appointment upon the approval of the Shareholders at the Annual General Meeting. Ms. Zhang's appointment as an executive Director shall be subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the Articles of Association. Ms. Zhang will not receive any directors' fee or salary for her service as an executive Director, but will continue to receive a remuneration package of RMB700,000 per year in her capacity as the secretary of the Board and a joint company secretary of the Company, which was determined with reference to her job responsibility and prevailing market rate. Ms. Zhang's annual emolument would be determined with reference to various factors such as her duties and performance as well as comparable market conditions and based on the recommendation from the Remuneration Committee and subject to the annual review conducted by the Remuneration Committee.

Mr. Zhao Yanchao ("Mr. Zhao Yanchao"), aged 46, has over 18 years of experience in the fields of corporate finance, equity investment and fund management. Mr. Zhao Yanchao is currently a partner of SAIF Partners (賽富投資基金), where he is responsible for the fund management operation. Mr. Zhao Yanchao had previously served in China International Capital Corporation Limited (中國國際金融股份有限公司) (a company listed on the Shanghai Stock Exchange (stock code: 601995) and the Stock Exchange (stock code: 3908)) and China Central Television (中央電視台), where he was involved in international initial public offering projects. Mr. Zhao Yanchao graduated from (i) the University of International Business and Economics with a Bachelor's Degree in Economics in 2000; and (ii) from the Harvard Business School with a Master's Degree in Business Administration in 2005.

Mr. Zhao Bingwen is currently the chairman and chief researcher of Langkun (Beijing) New Environmental Protection Technology Co., Ltd. (朗昆(北京)新環保科技有限公司), where he joined the company since 2015, and is primarily specialized in, among others, the research and measurement of carbon neutrality. Prior to that, from 2008 to 2012, Mr. Zhao Bingwen served as a project manager in Dinglian Holdings Co. Ltd (鼎聯控股有限公司). From 2012 to 2014, he served as an engineering director and assistant director at the Fifth Design Research Institute of the China Aviation Planning and Design Institute (Group) Co., Ltd. (中國航空規劃設計研究總院有限公司), a wholly-owned subsidiary of AviChina Industry & Technology Company Limited (中國航空科技工業股份有限公司) (a company listed on the Stock Exchange, stock code: 2357).

Mr. Zhao Bingwen's annual emolument would be determined with reference to various factors such as his duties and performance as well as comparable market conditions and based on the recommendation from the Remuneration Committee and subject to the annual review conducted by the Remuneration Committee.

As at the Latest Practicable Date, Mr. Zhao Bingwen confirmed that (i) he met the independence criteria as set out in Rule 3.13(1) to (8) of the Listing Rules; (ii) he has no past or present financial or other interest in the business of the Company or its subsidiaries or any connection with any core connected person (as defined under the Listing Rules) of the Company; and (iii) there are no other factors that may affect his independence at the time of his appointment.

Save as disclosed above and as at the Latest Practicable Date, none of the Directors mentioned above had and was deemed to have any interest or short position in any Shares and underlying shares of the Company and its associated corporations (within the meaning of Part XV of the SFO), nor did they have any interest in the debenture of the Company and its associated corporations.

Save as disclosed above, there is no other matter regarding the appointment of these Directors that needs to be brought to the attention of the Shareholders, nor is there any other information to be disclosed by the Company pursuant to any of the requirements under Rule 13.51(2)(h) to (v) of the Listing Rules.

The following is an explanatory statement required to be sent to the Shareholders by the Listing Rules in connection with the proposed Repurchase Mandate.

SHARE CAPITAL

As at the Latest Practicable Date, the share capital of the Company in issue comprised 1,960,000,000 Shares of nominal value of HK\$0.10 each. Subject to the passing of the resolution granting the Repurchase Mandate and on the basis that no further Shares are issued or repurchased after the Latest Practicable Date and up to the Annual General Meeting, the Company will be allowed to repurchase a maximum of 196,000,000 Shares which represent 10% of the number of the issued shares of the Company during the period ending on the earlier of (i) the conclusion of the next annual general meeting of the Company; or (ii) the expiration of the period within which the next annual general meeting of the Company is required by any applicable laws or the Articles of Association to be held; or (iii) the revocation or variation of the authority by an ordinary resolution of the Shareholders at a general meeting of the Company.

REASONS AND FUNDING OF REPURCHASES

The Directors believe that it is in the best interests of the Company and the Shareholders as a whole to seek a general authority from the Shareholders to enable the Company to repurchase the Shares. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or its earnings per Share and will only be made when the Directors believe that such a repurchase will benefit the Company and the Shareholders as a whole.

Repurchases of Shares will be financed out of funds legally available for the purpose and in accordance with the Articles of Association, the Listing Rules and the applicable laws and regulations of the Cayman Islands. Under the laws of the Cayman Islands, repurchases by the Company may only be made out of the profits of the Company or out of the proceeds of a fresh issue of Shares made for the purpose, or, if so authorised by the Articles of Association and subject to the provisions of the laws of the Cayman Islands, out of capital. Any premium payable on a redemption or purchase over the par value of the Shares to be purchased must be provided for out of profits of the Company or out of the Company's share premium account, or, if so authorised by the Articles of Association and subject to the provisions of the laws of the Cayman Islands, out of capital.

The Directors have no present intention to repurchase any Shares and they would only exercise the power to repurchase in circumstances where they consider that the repurchase would be in the best interests of the Company and the Shareholders as a whole. The Directors consider that if the Repurchase Mandate was to be exercised in full, it may not have an adverse impact on the working capital and/or the gearing position of the Company, as compared with the positions disclosed in the audited consolidated financial statements of the Company as at 31 December 2023, being the date to which the latest published audited consolidated financial statements of the Company were made up. The Directors do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or on the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

GENERAL

To the best of their knowledge, having made all reasonable enquiries, none of the Directors or any of their close associates, as defined in the Listing Rules, currently intends to sell any Shares to the Company or its subsidiaries, if the Repurchase Mandate is approved by the Shareholders.

The Directors have confirmed that, so far as the same may be applicable, they will exercise the power of the Company to make purchases under the Repurchase Mandate in accordance with the Listing Rules, the Articles of Association and the applicable laws of the Cayman Islands. Neither this explanatory statement nor the Repurchase Mandate has any unusual features.

No core connected person, as defined in the Listing Rules, has notified the Company that he or she has a present intention to sell any Shares to the Company, or has undertaken not to do so, if the Repurchase Mandate is approved by the Shareholders.

TAKEOVERS CODE

If as a result of a repurchase of Shares pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of Rule 32 of the Takeovers Code. Accordingly, a Shareholder, or a group of Shareholders acting in concert (within the meaning of the Takeovers Code), depending on the level of increase of the Shareholder's interest, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, to the best knowledge and belief of the Directors, Ms. Yang Min ("Ms. Yang") was deemed to be interested in a long position of 6,025,000 Shares and Mr. Yang Jiye ("Mr. Yang"), the son of Ms. Yang, was deemed to be interested in a long position of 1,314,061,666 Shares within the meaning of Part XV of the SFO, representing a total of approximately 67.35% of the issued share capital of the Company. In the event that the Directors exercised in full the Repurchase Mandate, the aggregate interests of Ms. Yang and Mr. Yang in the Company will be increased to approximately 74.83% of the issued share capital of the Company. To the best knowledge and belief of the Directors, such increase will not give rise to an obligation to make a mandatory offer under the Takeovers Code. Save as aforesaid, the Directors are not aware of any consequences which would arise under the Takeovers Code as a result of any repurchase of Shares pursuant to the Repurchase Mandate.

The Listing Rules prohibit a company from making repurchase on the Stock Exchange if the result of the repurchase would be that less than 25% (or such other prescribed minimum percentage as determined by the Stock Exchange) of the issued share capital would be in public hands. The Directors do not propose to repurchase Shares which would result in less than the prescribed minimum percentage of Shares in public hands.
