Computershare Hong Kong Investor Services Limited, the Company's branch share registrar in Hong Kong, acted as scrutineer for the vote-taking at the AGM.

In relation to resolution No. 2(a) and (b) above, the translation of Renminbi ("RMB") into Hong Kong Dollars ("HK\$") for the purpose of dividend payment in HK\$ is made at the rate of HK\$1.00 = RMB0.88941, which is the official exchange rate of HK\$ against RMB as quoted on 21 March 2017 by the People's Bank of China. The dividends will be paid on or about 26 May 2017 to shareholders whose names appear on the register of members of the Company on 19 May 2017.
