證券持有人的個人資料可被採用及以任何方式持有、處理及/或保存,以作下列用途:

- 遵守香港及其他地區的適用法律及法規;
- 以證券持有人(包括香港結算代理人(如 適用))的名義登記新發行證券或轉讓或 受讓證券;
