The capital reduction and share sub-division became effective before 9:00 a.m. on Thursday, 14 January 2021 resulting in the increase of the number of authorised shares of the Company. The authorised share capital of the Company became HK\$1,000,000,000 divided into 10,000,000,000 new shares of par value of HK\$0.10 each.
