The New Product can be overclocked and underclocked, and is suited for wider application scenarios, and at the same time, the New Product emphasizes user experience with the adoption of a hot swapping hash board design for convenient maintenance and removal, which is simple to install and easy to master.

As at the date of this announcement, pre-orders for the New Product from potential clients have already exceeded over 1,000 machines. The Company expects that once the New Product is in widespread operational usage, there will be considerable growth in the Group’s turnover.
