**ANNOUNCEMENT UPDATE ON THE PROPOSAL
PURSUANT TO RULE 3.7 OF THE TAKEOVERS CODE**

This announcement is made pursuant to Rule 3.7 of The Code on Takeovers and Mergers (the “**Takeovers Code**”).

References are made to the announcements of Powerwell Pacific Holdings Limited (the “Company”) dated 20 June 2013, 2 July 2013, 22 July 2013, 20 August 2013 and 23 September 2013 (the “**Announcements**”). Unless otherwise stated, capitalised terms used herein shall have the same meanings as those defined in the Announcements.

The Company wishes to continue to update the shareholders of the Company that, after making an enquiry with the Controlling Shareholder, Data Champion Limited (which is beneficially owned by Mr. Liu Tin Chak, Arnold (47.6%), Mr. Lam Chi Wai, Peter (23.8%) and Mr. Wong Yu Man, Elias (23.8%), being all executive Directors of the Company), as at the date of this announcement, there has not been further progress on the discussions between the Controlling Shareholder and the Potential Investor as referred to in the Announcement dated 20 June 2013 in relation to the Proposal. No further progress on the discussion and negotiation on the terms of the Proposal is due to the fact that the Company is currently during the blackout period for dealing the Shares by the Directors and the Proposal is yet to be materialised. As at the date of this announcement, no formal or legally binding agreement has been entered into between the Controlling Shareholder and the Potential Investor in respect of the Proposal.

Further announcement(s), including monthly announcement(s) setting out the progress of the discussions, will be made as and when necessary in accordance with the GEM Listing Rules and the Takeovers Code.

There is no assurance that any discussion mentioned in this announcement will either materialise or eventually be consummated, and the discussion may or may not lead to the making of an offer for the Shares. Shareholders and potential investors are advised to exercise caution when dealing in the securities of the Company.
